## AUCTION TERMS AND CONDITIONS:

- 1. The Fiori Self Loading Mobile Concrete Mixture Machine DBX50 (Model No.BX15H00121) 2017 ,BG-2A-0007 and the concrete pump can be inspected on working days during office hours 9 am to 5 pm by contacting Administrative Unit, Corporate Services Division from 21.06.2023 to 10.07.2023. The bidder/representatives coming for inspection are required to sign the register after the inspection of the Fiori machine.
- 2. Each bidder will have to deposit an earnest money to a tune of Nu. 5,000.00 (Nu. Five Thousand) only, in cash with the NHDCL latest by 11 AM BST on the day of the auction (14.07.2023) to be eligible and qualify to bid for the auction. The security amount is refundable to all the bidders except the highest bidder at the end of auction. On receipt of the earnest money, token card will be issued to identify the qualified bidder. No person will be allowed to bid in the auction without holding token card.
- 3. The highest bidder, whose bids are accepted, will have to deposit a spot payment of **25%** of the auctioned value on the day of the auction and balance within **10 (ten)** days from the day of auction, failing which accepted bid will be cancelled and the earlier deposits forfeited.
- 4. The earnest money of the highest bidder will be retained until the auction is completed as security for subsequent bid to be offered by them in respect of remaining item. On completion of the auction, the earnest money of the highest bidder will adjust against the auction value of item won by them. The earnest money of unsuccessful bidder will be refunded immediately at the end of the auction on the same day.
- 5. The highest bidder whose bid will be accepted by the auction committee will have to take delivery of the item within **10 (ten)** days from the date of the auction after full payment of auctioned value (cash /MBoB to NHDCL CD Account No.100912424 or demand draft drawn in favor of Chief Executive Officer, NHDCL). Failure to do so will result in the forfeiture of the deposit and the item will be proceed for the next auction. NHDCL will also not be responsible for any item that have been paid for, but not lifted within **15 days**, from the date of auction.
- 6. The auction committee reserves the right to accept the bid on the spot or at any subsequent date. In case of any dispute or problem, the decision of the committee will be final and binding.



- 7. The highest bidding shall have to make their own arrangement for transportation, loading/unloading and permit (if required) etc., after acceptance of the bid. The bidder shall have to pay all the local taxes, sale tax, surcharge or any other tax with the concerned authorities, if applicable, in addition to the amount offered.
- 8. All the bidders have to pay **Nu.300/- (Nu. Three Hundred**) only, as entrance fee, which is non-refundable.
- 9. While lifting the items the bidder shall not cause any damage to the properties of the office. In case of any damage, the same shall be made good/repaired by the bidder at his/her cost. The bidder shall leave not a single item behind that was included in auction list, if any left than it will be disposed at bidder's cost.
- 10. It will be assumed that interested parties bidding for items have inspected the item prior to the auction and that the bid offered is at their own liberty and judgment. It may be noted that the complaint whatsoever after the auction shall not be entertained. The office shall not be responsible for their usefulness or quality.
